PURPOSE FOR WHICH WATER IS AUTHORISED TO BE USED

Public Water Supply

QUANTITIES OF WATER AUTHORISED TO BE ABSTRACTED DURING A PERIOD OR PERIODS SPECIFIED

110,000 cubic metres per day, with a total of 28,900,000 cubic metres per annum.

AUTHORISED MEANS OF ABSTRACTION

Pumps

MEANS TO BE USED FOR MEASURING OR ASSESSING QUANTITIES OF WATER AUTHORISED BY THIS LICENCE

An efficient water meter shall be provided and installed by the Licence Holder before any water is abstracted in pursuance of this Licence and thereafter maintained in good order by the Licence Holder.

PROVISION FOR DETERMINING, BY MEASUREMENT OR ASSESSMENT, THE QUANTITIES OF WATER TAKEN TO HAVE BEEN ABSTRACTED DURING THE PERIOD OR PERIODS SPECIFIED

Records of the quantities of water actually abstracted each day shall be submitted quarterly to the Head of Environmental Services to the Authority.

OTHER CONDITIONS SUBJECT TO WHICH ABSTRACTION IS AUTHORISED

- (1) No abstraction may take place when the flow in the river below the intake is 1.207 cumecs (22.93 million gallons per day) or less except to the extent that additional water is released from Colliford and/or Siblyback reservoirs.
- (2) When the flow in the river is above 1.207 cumecs (22.93 million gallons per day) then no more than half the additional flow may be abstracted except to the extent that water is released from Colliford and/or Siblyback reservoirs.

REASONS FOR THE CONDITIONS OF THIS LICENCE

To enable the Authority to carry out its functions under the Water Resources Act 1963.

To provide for protected interests downstream and to preserve the ecology of the watercourse.
