1 BACKGROUND

South West Water is applying for a drought permit under section 79A of the Water Resources Act 1991 ("WRA 1991") or a temporary permit to abstract 8 ML/D from Hawk's Tor Pit for public supply and/or to refill Colliford reservoir directly.

1.1 The drought permit application documents

This document is part of a suite of documents which form the application for the drought permit as set out in Table 1. The structure and contents of the documents follows the requirements set out in **Appendix E** of the EA guidance on drought permits and drought orders ("The Drought Permit Guidance"), which was issued in 2019 and revised in 2021, with some adjustments to the sequence of documents / sections.

On 31 October 2022 all stakeholders listed in the table above were notified by E-mail by the intent to apply for a drought permit to adapt how we manage water in the Colliford Water Resource Zone (WRZ), following the period of prolonged dry weather.
